## Refunds, Returns, and Exchanges

To return an order, report lost or damaged merchandise, or report a shipment error, please contact Architexture, LLC by phone at **1-954-599-2316** (9am to 5pm ET), or by email at [info@myarchitexture.com](mailto:info@myarchitexture.com) **within 30 days of purchase**. Your item must be in its original unused condition to be returned, unless there is a manufacturer defect.

Include in your package a signed letter stating the reason for your return and the original invoice.

## Return Exceptions

Merchandise that has been submitted out of original packaging will not be accepted for return. Any **pre-approved** merchandise return received by us after 30 days of initial payment will be refunded as Appliqués by Arhitexture Store Credit.

## Restocking Fee

All items are subject to a 25% restocking fee. This will be deducted from your refund. We also do not refund the original shipping and handling that you paid on the order.

## Exchanges

If for some reason you would like to exchange your purchased design(s) for another, you may return the unopened merchandise to the address listed above, also notifying Architexture, LLC of your intent to exchange this product. You will be subject to a 25% restocking fee in this case, and will be responsible for all shipping charges.

## Shipping

All orders are shipped within 48 hours Monday - Friday 9am - 5pm.

Notification of shipment is sent via email, thru Fedex.com. Please refer to tracking numbers provided within the email.

Shipping charges are based upon your location and package weight/size of your product(s).

Orders placed before 4:30pm ET are usually shipped the same day. Orders placed after 4:30pm ET are usually shipped the next day. Orders placed after 4:30pm ET on Friday are shipped the following Monday.

Delivery times vary depending on your location, with the average delivery time of 3-5 business days.

If you did not receive your merchandise (i.e. lost in shipment) or received merchandise in damaged condition (due to shipping), and you report such loss within 30 business days of shipment, we will assist you in filing a claim with Fedex. We will refund payment or replace merchandise upon the successful completion of the Fedex Claim. Architexture, LLC, however, does not represent or guarantee that Fedex will accept any and all claims. Any such refunds or replacements are subject to Fedex terms and conditions. Achitexture, LLC is not responsible for lost, delayed, damaged or mishandled shipments. To help guard against late shipments or loss, we recommend the Next Day Air and 2nd Day shipping options.

If you believe there is an error in your shipment (i.e. wrong or missing product), you must report such error within the time limit of 30 days. Upon receipt of your report, the Architexture, LLC will investigate your report and determine the cause of the error. If we determine that the error was made on our part, we will immediately ship out the correct product upon receipt of the returned unopened product. If the error was on your behalf, we will ship out your requested product upon receipt of the returned unopened product, and payment for the new product, including a 25% restocking fee. You will also be responsible for all shipping charges.
